



Pool Rental Agreement 2022

The Pool is available for rental to any current member in good standing. (Dues paid) The renter must be at least 21 years of age and are responsible for their own set up and clean up. The host who has rented the pool in his/her name must be present at all times at the function for which the pool is rented and must be the primary host of the event. Under no circumstances can anyone rent/reserve the pool on behalf of a third party. We require a two weeks' notice to allow for scheduling of the guards.

The WHOA pool is available for private parties from: 9am-11am or 8pm-10pm Sunday thru Saturday. Private rental is NOT allowed during regular open swim hours 11:30am-8pm Sun-Sat.

***NOTE: MORNING HOURS ARE NOT AVAILABLE MON-FRI DURING SWIM TEAM SEASON June 8th – July 24th**

RULES:

1. All WHOA policies, agreements, rules, and regulations must be observed and are enforced. (See attached copy of the pool rules)
2. Set up may not begin any earlier than 9am or 8pm.
 - i. Picnic tables, chairs, and loungers are available and included with your rental. If moved, they must be put back in original position.
 - ii. There is no cooking allowed inside the gated pool area.
3. Alcoholic beverages are PROHIBITED.
4. Music should be set at an acceptable level, so that it is only audible within 50 feet. Please be respectful of our neighbors.
5. Clean up must be completed by 11:30am or 10:30pm.
 - i. Pool deck, grounds, and pavilion must be swept and clean from debris.
 - ii. All trash must be bagged and put in the proper receptacles in the parking lot.
 - iii. Bathrooms must be cleaned.

Rental Fee:

Rental fee: \$155 (includes 2 lifeguards)

Refundable Deposit: \$100

NOTE: All rental fees must be paid before the party begins. The \$100 deposit will be refunded within 48 hours if the rental agreement has been followed and approved.

CANCELLATION: We require notification of cancellation at least 48 hrs before the event for a full refund. For cancellation within 48 hours there will be a \$50 cancellation fee. 2022 Pool Rules

Pool will be open daily from 11:30am-8pm
(Pool will CLOSE @ 4pm on 6/21, 7/7 & 7/14 for swim meets)

1. Children 12 and under MUST be accompanied by an adult.
2. Obey the lifeguards at all times.
3. Appropriate swim attire must be worn. No undergarments, thongs, or overly revealing garments. Street clothes or street shoes are not allowed in the pool.
4. Children wearing a floatation device must be accompanied by an adult at all times unless capable of passing a lifeguard administered swim test. (Swim Test: Must be able to swim 1 length of the pool or 2 widths and tread water for 30 seconds)
5. No running, pushing or horseplay.
6. Foam balls, noodles and toys, are only permitted with permission of the Lifeguards.
7. Swimmers are not to hang on ladders or safety lines.
8. No diving in the shallow end. No diving off sides of pool, which are clearly marked.
9. Any person having an infection or communicable disease is prohibited from use of the pool. Open cuts, blisters, etc. must remain covered.
10. All Scuba gear, diving equipment, and snorkels are strictly prohibited.
11. No smoking. No drinking. Anyone intoxicated will be asked to leave.

WADING (BABY) POOL:

1. Swimmers six years and under can use the wading pool. Children MUST be accompanied by a responsible adult.
2. No pushing, running, or horseplay in the wading pool area.

Please keep the gate closed at all times!

POOL CLOSING DUE TO WEATHER GUIDELINES:

1. If lightening is observed the pool will be vacated immediately and closed. If thirty minutes have passed since the last lighting, then the pool may be reopened.
2. If the temperature on the thermometer posted at the pool reads 69⁰ or less, the pool will close at the Head Lifeguard's discretion. The temperature will be rechecked periodically to determine if the pool will be reopened. All closings related to weather will be reported to the Board and posted on our Facebook page: Westview Homeowners' Association. TAG SYSTEM AND SIGN IN POLICY

1. Pool tag must be scanned upon entry.
2. A database listing of The Westview Homeowners Association, provided and updated regularly by the Board, will be used as a reference to cross check for those members who have been issued tags.
3. Any member not marked as current on dues payments on the Master List is denied entry into the pool area. **NO TAGS – NO ENTRY – NO EXCEPTIONS!**
4. Should there be a discrepancy, Contact the board at whoaconnect@gmail.com.
5. Guest policy:
 - a. WHOA members 13 years and older are responsible for signing in guests. The homeowner is responsible for the guests' actions while on WHOA property.
 - b. Once a guest is signed in the privilege is given for that day only.
 - i. Guests' first and last names must be clearly recorded
 - ii. Guests must be accompanied by WHOA member while on WHOA property
 - iii. WHOA reserves the right to limit the number of guests
 - iv. Any special requests must be cleared by head Lifeguard or Board member in advance

NOTE: Pool privileges for WHOA members are not transferable. WHOA reserves the right to ask for identification.
